As in our past Mechanics Workshops, your staff will receive training that will assist you in improving your fleet operations and equipment repair.

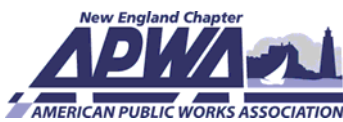
